



### Nebraska Olmstead Plan Focus Groups

In December 2019, the Nebraska Department of Health and Human Services (DHHS) issued the state’s first Olmstead Plan (the Plan). The Plan identified the State’s seven goals to enhance opportunities for individuals with disabilities to live, learn, work, and enjoy life in the most integrated setting to meet their needs, and the strategies to be carried out by various state agencies to help reach those goals. The Technical Assistance Collaborative, Inc. (TAC) is under contract with DHHS to assess the State’s progress with implementing the Plan. As part of the evaluation of progress for the implementation of the Plan, TAC is seeking input from stakeholders to learn how life for individuals with disabilities has been impacted as a result of the plan’s implementation.

You are invited to join the focus group that best represents your role in serving and supporting Nebraskans with disabilities to share input about progress, challenges, and recommendations for the updated Plan.
